

NARRATIVE

UNIT # 1 WAS TRAVELLING FROM THE WEST TO THE EAST ON WHITE RD. UNIT # 2 WAS STOPPED FOR THE RED LIGHT, FACING FROM THE WEST TO THE EAST ON WHITE RD AT MCDOWELL RD. UNIT # 1 FAILED TO MAINTAIN ASSURED CLEAR DISTANCE, AND STRUCK UNIT # 2 IN THE REAR.

THE PASSENGER OF UNIT # 2 COMPLAINED OF POSSIBLE NECK PAIN AND WAS TREATED AND RELEASED AT THE SCENE OF THE CRASH.
