



UNIT 1 WAS STOPPED FOR THE STOP SIGN ON FIRST AVENUE FROM WEST TO EAST AT THE INTERSECTION OF US 62. UNIT 2 WAS TRAVELLING FROM NORTH TO SOUTH ON US 62 AT THE INTERSECTION OF FIRST AVENUE. UNIT 1 FAILED TO YIELD AT THE STOP SIGN WHILE MAKING A LEFT TURN TO GO NORTH ON US 62 AND STRUCK UNIT 2.
