



NARRATIVE
UNIT 3 WAS STOPPED IN TRAFFIC FACING FROM EAST TO WEST ON STRINGTOWN RD. UNIT 2 WAS DIRECTLY BEHIND UNIT 3 SLOWING IN TRAFFIC (EAST TO WEST ON STRINGTOWN RD.). UNIT 1 WAS TRAVELING DIRECTLY BEHIND UNIT 2 (EAST TO WEST ON STRINGTOWN RD.). UNIT 1 FAILED TO ASSURE CLEAR DISTANCE AHEAD AND STRUCK THE REAR OF UNIT 2. THE FRONT OF UNIT 2 THEN STRUCK THE REAR OF UNIT 3.
