

UNIT 2 WAS TRAVELING FROM NORTH TO SOUTH ON US ROUTE 62. UNIT 1 WAS TRAVELING FROM SOUTH TO NORTH ON US ROUTE 62 AND MAKING A LEFT TURN ONTO BURR OAK DR. UNIT 1 FAILED TO YIELD WHILE MAKING THE LEFT TURN AND CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE RIGHT FRONT WITH ITS LEFT FRONT.


