

## Incident Report Narrative

NARRATIVE  
 UNIT#1 WAS TRAVELING FROM THE SOUTH ON GANTZ ROAD TURNING TO THE WEST (LEFT TURN) INTO A PRIVATE LOT. UNIT#2 WAS TRAVELING FROM NORTH TO SOUTH ON GANTZ ROAD IN THE WEST (CURB) LANE. UNIT#2 STRUCK UNIT#1 CAUSING UNIT#1 TO ROTATE CLOCKWISE. DURING THE ROTATION UNIT#1 STRUCK UNIT#3 CAUSING DAMAGE TO ALL OF THE UNITS. UNIT#3 WAS STOPPED FACING WEST TO EAST ON THE PRIVATE LOT. UNIT#1 IS AT FAULT FOR FAIL TO YIELD ON A LEFT TURN.


