


UNIT#1 WAS TRAVELING FROM NORTH TO SOUTH ON THE I-71 SOUTH EXIT RAMP TO STRINGTOWN ROAD AND WAS IN THE MIDDLE LANE. UNIT#2 WAS TRAVELING FROM NORTH TO SOUTH ON THE I-71 SOUTH EXIT RAMP TO STRINGTOWN ROAD AND WAS DIRECTLY IN FRONT OF UNIT #1 STOPPED IN TRAFFIC. UNIT#2 DID NOT SEE THAT UNIT #1 HAD STOPPED AND STRUCK UNIT #2 IN THE REAR.. UNIT#1 IS AT FAULT IN THE ACCIDENT FOR ASSURED CLEAR DISTANCE.
