## Rules and Regulations

**EVENT HOURS:** Friday, Aug. 23 5-9:30 p.m.  
Saturday, Aug. 24 5-9:30 p.m.  
(gates will open one hour prior each day)

**CHECK IN:** Vendor check-in may begin as early as 10 a.m., Friday, Aug. 23 and **must be completed by 2 p.m.** Please be courteous while unloading and allow vehicle space for the booth next to you. When you have completed unloading, you will be asked to promptly move your vehicle to a designated parking area. All vendors are required to be set up and operational by the start time each day. No vehicles will be permitted to stay on event grounds during the event. Vendors are expected to stay open and staffed during all event hours.

**VEHICLE PARKING:** Each exhibitor will be given a parking pass for one vehicle and/or supply trailer. Parking is available in the reserved parking area.

**MERCHANDISE:** The Grove City's Balloons and Tunes Festival Committee has final say on merchandise sold. Only items listed on the original contract may be displayed and sold.

### **MERCHANDISE VENDOR RESTRICTIONS:**

Include the following, but are not limited to:

- Merchandise vendors must operate within their designated areas, items shall be sold in the booth area only. Roving sales are prohibited.
- Merchandise vendors are prohibited from selling food or drinks.
- Merchandise vendors are prohibited from gaming operations.

**PETS:** Pets are prohibited unless assisting individuals with handicaps.

**LIABILITY:** Vendors exhibit at their own risk. The City of Grove City and Beulah Park are not responsible for any theft, damage or accidents occurring during the festival or resulting there from.

**RETURNED CHECKS:** A returned check fee of \$30.00 will be assessed should a check be returned by the bank.
