

ORDINANCE NO. C-36-60

An ordinance to amend Ordinance C-4-59 providing for annual appropriations.

WHEREAS, it is necessary in the administrative transition from a village to city status under the City Charter to provide for establishment of funds and making of annual appropriations and,

WHEREAS, such transition has caused an emergency in the Finance Department with respect to authorizing payment of the usual city bills, and such emergency directly affects the health, safety, and morals of Citizens of Grove City,

NOW, THEREFORE, Be It Ordained by the Council of the City of Grove City that:

Section 1. Sections 1 - 19, inclusive, of Ordinance No. C-4-59 is amended to read as follows:


