

ORDINANCE C-55-08

AN ORDINANCE TO APPROPRIATE \$170,711.25 FROM VARIOUS FUNDS AND TO REAPPROPRIATE \$140,000.00 FOR BUREAU OF WORKERS' COMPENSATION PAYMENTS

WHEREAS, Bureau of Workers' Compensation rates have increased significantly from last year; and

WEHREAS, it is necessary to appropriate additional funds from various accounts to cover these increases; and

WHEREAS, \$140,000.00 was appropriated into an incorrect account in the 2008 Appropriation Ordinance and it is necessary to re-appropriate this amount into the correct account.



SECTION 1. The following is hereby appropriated from the unappropriated monies of the stated Fund for the Current Expense of Workers' Compensation Payments:

SECTION 3. This ordinance appropriates for current expenses and shall therefore go into immediate effect.




