

ORDINANCE NO. C-60-09

AN ORDINANCE DECLARING THE NECESSITY OF AND DETERMINING TO PROCEED WITH A PUBLIC IMPROVEMENT TO BE PAID FROM A SPECIAL ASSESSMENT FOR THE PURPOSES OF RELOCATING, WIDENING, RECONSTRUCTING, AND IMPROVING HAUGHN ROAD FROM ITS EXISTING LOCATION, WEST TO GATEWAY WEST DRIVE AND PAYING FOR EXPENSES RELATED THERETO

WHEREAS, the City of Grove City previously adopted Resolution No. CR 35-09 declaring the necessity for a public improvement for the relocation and improvement of Haughn Road by adding an east/west connector across the property owned by The Solid Waste Authority of Central Ohio to Gateway West Drive; and

WHEREAS, the City desires to proceed with the Project; and

WHEREAS, SWACO, as the sole landowner, did not file an objection to the assessment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVE CITY, STATE OF OHIO, THREE-FOURTHS OF ALL OF THE MEMBERS ELECTED CONCURRING, THAT:

SECTION 1. It is hereby determined to be necessary to make a public improvements in the City by relocating, widening, reconstructing, and improving Haughn Road from its existing location, west to Gateway West Drive, including the intersections therewith, with related signage and striping, bike paths and sidewalks, storm sewer and drainage, utility relocation and improvements, curb and gutters, street lightning and other te improvements, paying engineering, design and legal expenses related thereto.

SECTION 2. It is hereby determined to proceed with the construction of the Project in accordance with the plans, specifications, profiles and cost estimates that are on file with the office of the Clerk.

SECTION 3. Council hereby adopts the estimated assessment prepared and filed with Resolution No. CR 35-09 and attached hereto.

SECTION 4. Any claims for damages filed in accordance with R.C. §727.18 shall be judicially inquired into after completing the Project.

SECTION 5. The City Administrator and other appropriate officials of the City are hereby authorized and directed, as soon as the funds are available, to make and execute a contract for the construction of the project in accordance with the bidding and advertising requirements set forth in the City of Grove City Codified Ordinances.

SECTION 6. The Clerk of Council is hereby directed to have delivered a certified copy of this Ordinance to the County Auditor within fifteen days after passage hereof.

SECTION 7. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Revised Code Section 121.22.

SECTION 8. This Ordinance shall take effect at the earliest opportunity allowed by law.


