

A RESOLUTION TO INITIATE AN AMENDMENT TO SECTION 8.01 OF THE CITY CHARTER

WHEREAS, Section 8.01 of the City Charter provides that a recall may be effectuated by "twenty-five persons"; and

WHEREAS, it appears that this requirement is an obvious error in that, it should read "twenty-five percent"; and

WHEREAS, Section 9.04 of the City Charter vests the power in council to initiate amendments to the Charter;

NOW, THEREFORE, be it resolved by the council of the City of Greve City, Ohio, that,

Section 1. Amendment of Section 8.01 of the City Charter be initiated to read as follows:

"... A recall may be started by the filing with the clerk of the city a petition signed by qualified voters equal in number to twenty-five percent of those who cast ballots for mayor at the last preceding city election, ..."

Section 2. The clerk of council is hereby directed to certify this resolution to the city clerk.

Section 3. The city clerk is hereby directed to certify the question to be resolved to the Franklin County Board of Elections according to law in sufficient time as to have the issue decided at the regular municipal election next ensuing.

Section 4. The <sup>clerk of council</sup> city clerk is hereby authorized and directed to perform all other duties as are required by law to effectuate the purpose of this resolution.
