January 03, 2007

Organizational Meeting

1. The Organizational meeting of Council was called to order by Clerk of Council, Tami Kelly at 7:00 p.m. in the Council Chambers, City Hall, 4035 Broadway. Roll call was called and the following were present:

10. President Berry moved to declare the Clerk of Council the Designee for H.B.9 - Open Records Certification; seconded by Ms. Klemack-McGraw.




11. President Berry moved to accept the Rules of Council; seconded by Ms. Klemack-McGraw.
