Regular Meeting

1. The Council of the City of Grove City, Ohio met in regular session on the 7th day of January, 1980 in the council chambers with the following members present:

Ronald Margello


2. The Clerk called for the nomination for President of Council and Mr. Dooley nominated John Hampson for President; seconded by Mr. Douglas.

3. Mr. Hampson took the chair and assigned the seats starting on his far right in this order: Mr. Douglas, Mr. Kingsmore, Mr. Hampson, Mr. Margello and Mr. Dooley.
4. President Hampson assigned Mr. Margello, Chairman of Finance; Mr. Douglas, Chairman of Zoning, Mr. Kingsmore, Chairman of Service and Mr. Dooley, Chairman of Safety.
5. Council recessed to committee of the whole for discussion of the agenda.
6. Mr. Hampson moved to suspend the rules of council to amend the agenda to include Resolutions CR-1-80, CR-2-80, CR-3-80, CR-4-80 and to act on them at this time.
7. Mr. Hampson read the Resolutions of Appreciation and present them to former Mayor Michael T. Brandt, Former Councilman and new Mayor Robert E. Evans, Former Councilman James McDonald and Former Councilman Harold Walter.
8. Council gave their approval to the transfer of a D5 Liquor Permit from Meredith E. Miller d/b/a Mike & Ritas Lounge to R. Phillips Enterprises, Inc. d/b/a Russ Lounge, 4030 Broadway.
9. There was no discussion on the two ordinances on the agenda. Mike Ehrin, 3339 Parkridge Drive spoke to council about snow removal on the streets in that subdivision and also asked that the franchise with Warner Cable TV be reviewed. He stated that they in that subdivision have been unable to obtain Cable or Qube from Warner.
10. Council reconvened; called to order by President Hampson.
11. Ordinance No. C-1-80 (to amend code for salary ranges for unclassified employees) was given its first reading. Second reading and public hearing will be on January 17.
12. Ordinance No. C-2-80 (to issue notes for S/W Blvd.) was given its first reading. Second reading and public hearing will be on January 17.
13. Mayor Evans gave the Mayor's report for the month of December and Mr. Dooley moved it be accepted; seconded by Mr. Margello.
