5. Council gave their consent for a C1 and C2 beer permits to the Ohio Department of Liquor Control for Jays Beer Drive In at 800 Stringtown Road.

7. Mr. Kingsmore opposed the \$4,000 estimated on Ord. C-23-76 for paving of the parking area on W. Park Street. Mr. Kingsmore feels that the city has invested enough money into this lot to help the downtown businesses and feels that the \$4,000 should go to improving streets.

 Mr. Plymale stated that the parking area was not part of the ordinance and if council wanted to include money for its paving that the ordinance should be amended to include the parking area or it should be done by a separate ordinance. It was decided by Council to amend Ord. C-23-76 to include the parking area.
