1 The Council of the City of Grove City, Franklin County, Ohio met in special session on the seventh day of March, 1972 at 7:30 p.m. in the Council Chambers located in the Municipal Building, 42 East Park Street, Grove City Ohio with the following members present:

2 Council recessed to committees.

3 Citizens who spoke to council concerning CR-10-72 were: Roland Edwards, Robert Lewis, Dr. Altomare, Bruce Price, Shirley Johnston, Mr. Johnston, Barbara Ferret and Jim Burton.

4 Mayor Brandt suggested as an alternative to Resolution (a moritorium on sewer taps) CR-10-72 that all building permits applied for first be submitted to the Planning Commission, then the Zoning Committee (appointed in March) and then to the Council.

5 Ordinance No. C-19-72 (vetoed by Mayor Brandt on March 11, 1972) was discussed.

6 Clerk read a letter addressed to Mr. Allen Kiel from the Galbreath Mortgage Company concerning the above ordinance.

7 Council reconvened; called to order by President Kingsmore.

8 Resolution No. CR-10-72 (to impose a moritorium on sewer taps) was given its first reading.

9 Mrs. Myers moves that on Resolution CR-10-72 the rules of council be suspended and the waiting period waived; seconded by Mr. McDonald.
