This provision shall apply to members who are called to work while on off-duty. This was seconded by Mr. Hampson.

President Hampson called a special meeting of Council for April 28 at 7:00 p.m. for the discussion and possible action on Ordinance C-28-80.


Mr. Hampson stated that the council and the township trustees are going to work together to seek funds for a senior citizens center as a cooperative venture.
