June 6, 1977

Regular Meeting

1. The Council of the City of Grove City met in regular session on the sixth day of June, 1977 in the council chambers located in the Municipal Building with the following members present:

2. The Rev. Father Hoch gave the invocation.
3. Mrs. Myers moved to dispense the reading of the minutes; seconded by Mr. Walter.

6. Mayor Brandt presented a certificate of recognition to Father Hoch for his service to the community.
7. Council recessed to committees.
8. Mayor Brandt spoke to council on Ordinance C-40-77 (to increase salary of council and the Mayor). Mayor Brandt stated that \$6,000 is still not enough money to pay a part time mayor and that he feels that the city is large enough to warrant a full time mayor or to go to a city manager-council type of government. He also stated that he would like to see a citizens committee organized to study these possibilities. He referred to his letter of June 1 to the council.
9. Pastor Taylor, representing Dr. Wiley and the Southwest Ministerial Association, asked if council were going to authorize a petition for the ballot in reference to the pornography issue. Mr. Evans stated that it was not necessary for the council to issue a resolution directing the Association to petition for an initiative; that this can be done by them with the aid of their own legal counsel.




