24. Ordinance No. C-57-77 (Amend zoning code-light industry) was given its first reading. Second reading and public hearing will be on July 11.


25. Ordinance No. C-58-77 (Amend zoning code-set back lines on thoroughfares was given its first reading. Second reading and public hearing will be on July 11.
