MINUTES

November 15, 1999

Organizational Meeting

1. The City Council organizational meeting was called to order by Clerk of Council, Tami Kelly at 10:25 p.m. in the Council Conference Room, City Hall, 4035 Broadway. The following were present:

Also in attendance were: Mike Milovich and Richard Stage.

2. Ms. Kelly reminded the members of Council of the message that was forwarded to them from Maria Klemack, requesting that this meeting be postponed due to her being out of town on business. Public Service:	Mr. Fulton	Finance:	Mr. Eversman

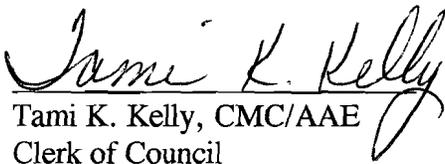
There being no objections, these assignments were approved by unanimous consent.

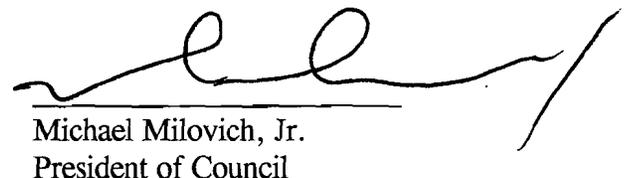
12. Mr. Eversman moved to adopt the Rules of Council; seconded by Mr. Bennett.
