1. Council met in special session with President Harold Norris in the Chair.
2. Roll call showed the following councilmen present. Mr. Norris, Mr. Rothwell, and Mr. Brinkman. Mr. Canter was absent due to illness, and Mr. Wagner was not present.
3. Mr. Norris requested the minutes of the November 22, 1960 meeting not be read since copies were not available for all councilmen and since all councilmen were not present.
4. Ordinance C-85-60-An Ordinance to Make Appropriations for Current Expenses and Other expenditures for the City of Grove City, State of Ohio, During the Year 1961 was referred to the Finance Committee.
5. Ordinance C-83-60-An Ordinance to Establish Standards and license Rates for Heating, Ventilating, and Air Conditioning Installer, and to Amend Ordinance 269, and to Declare an Emergency was referred to the Service Committee.
6. Ordinance C-84-60-An Ordinance to Establish Rates for Plumbing licenses and to Amend Ordinance 281 and to Declare an Emergency was referred to the Service Committee.
7. Mr. Thomas, Law Director, advised that pursuant to Article #506 of the Grove City Charter - this meeting constituted the public meeting required by law regarding the annual appropriations ordinance.
8. Council adjourned for various committees to meet.
9. Council reconvened and was called to order by President Norris.
10. Mr. Brinkman, Chairman of the Finance Committee, suggested postponing Ordinance C-85-60-An Ordinance to Make Appropriations for Current Expenses and Other Expenditures for the City of Grove City, State of Ohio During the Year 1961 until next special council meeting.
11. Mr. Norris acting Chairman of the Safety Committee, suggested postponing Ordinance C-83-60-An Ordinance to Establish Standards and License Rates of Heating, Ventilating, and Air Conditioning Installer, and to Amend Ordinance 269 and to Declare an Emergency; and Ordinance C-84-60-An Ordinance to Establish Rates for Plumbing licenses and to Amend Ordinance 281 and to Declare an Emergency, until next special Council meeting.


